### PAYMENT SCHEDULE

- Payment is due upon delivery
- If you are sharing a booth, the party responsible for renting the booth from the association is the only exhibitor we invoice.

### METHOD OF PAYMENT

- For your convenience, we accept cash, checks, money orders drawn on U.S. Banks in U.S. funds, Mastercard, Visa, Discover, and American Express.

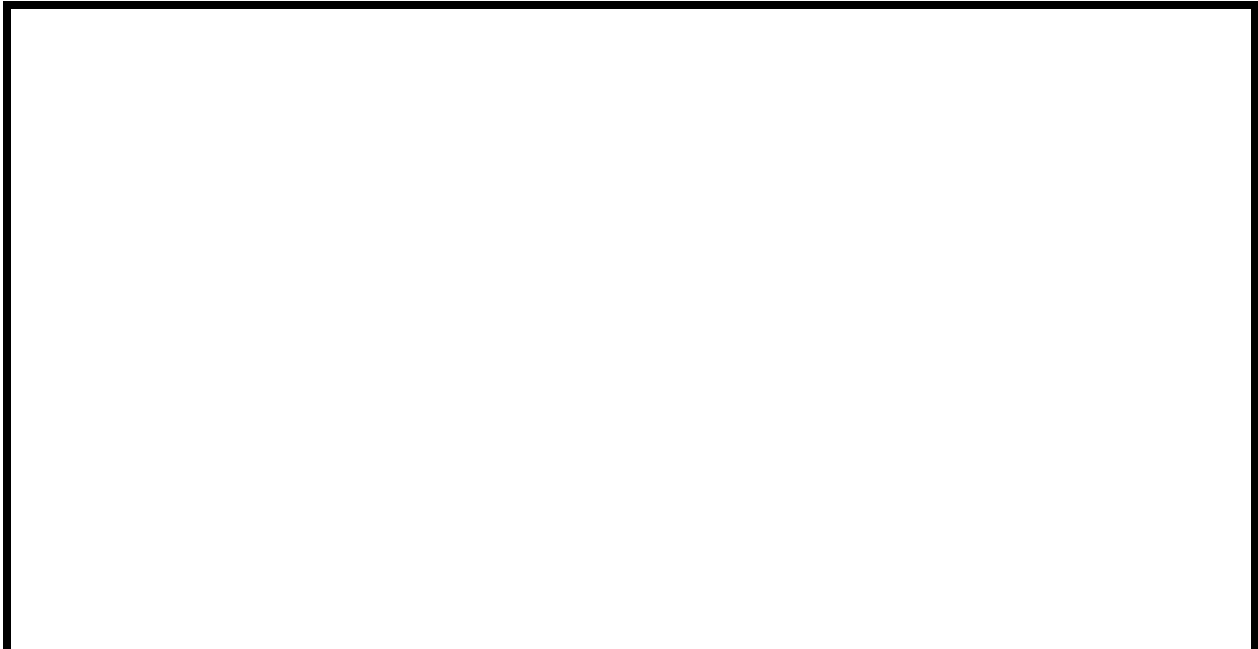
